ABOUT PUSHPAGIRI COLLEGE OF NURSING

The Pushpagiri College of Nursing is a Christian minority educational institution established, maintained, and administered by the Pushpagiri Medical Society. The College of Nursing with an annual intake of 50 students for B.Sc. Nursing was started in the year 2002. The M.Sc. Nursing program was started in 2011 with 13 seats under 3 specialties - Medical Surgical Nursing, Child Health Nursing, and Mental Health Nursing. The seats for B.Sc. Nursing was enhanced to 75 in the year 2021. The college is recognized by the Indian Nursing Council (I.N.C.) as well as the Kerala Nursing and Midwifery Council (KNMC) and is affiliated with the Kerala University of Health Sciences (KUHS), Thrissur.

ADMISSION TO B.Sc. NURSING COURSE on N.R.I. CATEGORY SEATS Academic Year 2025-26 - Prospectus & Instructions to the Applicants

01. Applications for admission to first-year B.Sc. Nursing (Academic year 2025-26) in **NRI** category seats at this college is being invited based on this prospectus. The annual intake is 75 out of which 11 Open Merit (Eleven) seats are for the NRI category. All NRI seats are under open category.

02. **Academic Eligibility:** As per Indian Nursing Council norms, the candidates should have passed +2 class with 12 years of school-ship with 50% aggregate in Physics, Chemistry, Biology & English.

As per norms of the Kerala University of Health Science (KUHS) for admission for B.Sc. in nursing, the minimum educational requirements shall be the passing of the Higher Secondary School Certificate Examination (12 years course), Or Senior School Certificate Examination (10+2) Or An equivalent with 12 years of schooling from a recognized board or university with Science (Physics, Chemistry, Biology) and English with a minimum of 50% aggregate marks.

Candidates who have passed their qualifying Examination from authorities other than the State of Kerala, except CBSE and ICSE, shall produce the certificate of recognition and equivalence of the qualifying examination from Kerala University of Health sciences / Directorate of HSE, Kerala.

3 Age Requirements: Applicants must be at least 17 years of age on 31st December 2024 (as per the date of birth being shown on the Matriculation or equivalent certificate).

4 Eligibility for admission to N.R.I. Category Seats: According to the GO (MS) No.243/2014/H&FWD dated 06.08.2014; "An Applicant who depends upon his/her Father/Mother/Brothers and Sisters (inclusive of first cousins)/ Husband/ Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.

Copy of the following documents duly attested by a Gazetted Officer to prove the NRI status shall be submitted along with the application:

5 I. Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.

5 ii Copy of the relevant pages of the passport containing visa details that is attested by the Embassy.

iii. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.

iv. A self-affidavit/declaration (find specimen format Annexure-1) by the NRI relative (Sponsorship Certificate).

v. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS) No.243/2014/H&FWD dated 06.08.2014.

06. *FEE STRUCTURE: A selected applicant in NRI category is liable to pay the following fees:

Note: *Fees are subject to change in accordance with ASC / FRC order.

Apart from the schedule of fees given above, the students will be required to pay the proportionate administration/affiliation/examination fee, etc. payable to the University from time to time. Medical insurance fee & Mess fee will be charged separately.

07. Scheme of Admission:

- i. The application fee can be paid either by online gateway or Demand Draft to “Pushpagiri College of Nursing” payable at CSB Bank, Thiruvalla.
- ii. Register into www.collegeofnursing.pushpagiri.in after selecting the application portal from the same site
- iii. Complete the online application with the details of fee remittent, your personal details and qualifying examination details.
- iv. Before doing the final submission countercheck all the details you entered and followed by final submission.
- v. The online application can be confirmed only on the receipt of the printout and verification of documents. In case of any discrepancies between the online date and the details on the copies of the relevant documents, the latter alone shall be accepted.

vi. The application fee is Rs. 1000/- (Rupees one thousand only) and if paid by online payment gateway will be receipted on the hardcopy of the application when print out. Or if the application fee is paid as D.D in favor of Pushpagiri College of Nursing, the original D.D shall be enclosed along with hard copy of online application print out.

vii. The dully filled application form should be submitted together with self-attested copies of necessary certificates (The original documents have to be submitted at the time of admission).

viii. The last date for receipt of duly signed print out of online application at the Pushpagiri College of Nursing office (Administrative Office-CON) on or before 21st August 2025 3:00 pm.

ix. The applicants, at their own interest, are advised to send the applications by Registered Post. *The college cannot be held responsible for non-receipt or late receipt of applications, under any circumstances.* The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the pre-scribed format will be summarily rejected.

x. Process of preparing the rank list

- a) Received applications will be scrutinized for the candidate's eligibility.
- b) Incomplete and /or late received applications and applications not in the prescribed format will be rejected.
- c) Based on the mark obtained for Physics, Chemistry, Biology and English for Plus two (Second year mark), eligible candidate rank list will be prepared.

xi. Self-attested copies of certificate/ Documents to be submitted along with the hard copy of application include:

- a) School Leaving Certificate (S.S.L.C.) book/ equivalent board certificate as proof of age and date of birth of student establishing that the student has completed 17 years of age as on 31.12.2024
- b) Certificate and mark list of SSLC/ 10th Std.
- c) Certificate and mark list of plus Two/ 12th Std.
- d) Proof for NRI status (Ref. no. 5 above).
- e) Course & Conduct certificate from the institution last studied in proof of clause (Prohibition of Ragging) preferably issued within 6 months.
- f) Medical fitness certificate and Vaccination certificate (COVID-19 &

Hepatitis B)- Certificate of Medical Fitness from an authorized Medical Officer with MBBS or higher qualification certifying that the candidate is fit to undergo the course.

g) Eligibility/ Equivalency certificate from Kerala University of Health Sciences/Directorate of HSE wherever applicable.

h) Transfer Certificate (T.C)

i) Migration certificate if applicable.

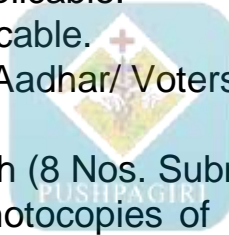
j) Nativity certificate if applicable.

k) Copy of photo ID proof (Aadhar/ Voters ID/ Passport)- (Submit at the time of admission)

l) Passport size photograph (8 Nos. Submit at the time of admission) m)

Additionally two sets of photocopies of all the above certificates/ Documents attested by Gazetted officers have to be submitted at the time of admission.

n) Students and Parents shall, at the time of admission, furnish an affidavit to the effect that the students will not indulge in any form of ragging.



- 08.** Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the College midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent "Civil Court.
- All students who get selected should get themselves vaccinated against Hepatitis, Chickenpox & Covid before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 09.** Every student is required to adhere strictly to the Code of Conduct of the college.
- 10.** Ragging is strictly prohibited. If it is found during the admission or any time thereafter that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution.
- 11.** Whoever commits, participate in, abet or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 12.** Without prejudice to the directions of the Nursing Councils/Government/ University, the decision of **Pushpagiri Medical Society** shall be final on all matters with regard to admission.
